The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2012-13 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 06-10-2012

- Computer to student ratio should be maintained at 1:6 from the existing 1:18. 60 more computers are to be added
- 2. 1500 more books should be procured to the library
- 3. Existing Teacher to student ratio is 1:34 should be improved to 1:15
- 4. Majority of the students are scoring more than 90% internal examinations
- Internal examinations should be conducted seriously
- Equipment like plate & frame filter press laboratory, tray drier, stem distillation apparatus etc.
 should be procured.
- 7. Gas chromatography, FTIR should be procured
- 8. Internet facility should be extended to the library
- 9. Furning cupboards should be procured to the laboratories
